The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of Uganda shillings one hundred thousand only UGX 100,000 (Uganda Shilling One Hundred Thousand Only Shillings) The method of payment will be by Bank Payment Advice Form obtainable from National Forestry Authority.
